

As a water industry association, Water Professionals International (WPI) had a remarkable year in 2022. With our new award-winning rebrand, increased member engagement, and successful growth and improvement of our testing and certification programs, we have made significant strides in ensuring the sustainability of our workforce initiatives. This year has been a vital part of the journey toward achieving our goals, which involve expanding our services to better serve our members and clients. Let's take a closer look at the notable milestones of our progress, as well as the initiatives we are planning for 2023 that will take us to even greater heights.

In 2022, we introduced the new award-winning rebrand of ABC to Water Professionals International (WPI), which was a significant step toward modernizing our association. Our organization has always been a symbol of excellence in the water industry, and we want to ensure that our new identity accurately represents our goals and values. With fresh branding that reflects our vision and purpose, we are confident that our efforts will be more meaningful to our stakeholders, members, and clients.
